In accordance with Article 226 of Law 6/2023, of 17 March, on Securities Markets and Investment Services and Article 17 of Regulation (EU) 596/2014 of the European Parliament and of the Council of April 16, 2014 on market abuse, as well as the prospectus relating to the initial public offering of ordinary shares of Cirsa Enterprises, S.A.U. (the "Offering" and "Cirsa" or the "Company", respectively) and the admission to listing of such ordinary shares on the Barcelona, Bilbao, Madrid and Valencia Stock Exchanges ("Admission" and the "Spanish Stock Exchanges", respectively) (the "Prospectus"), the Company hereby announces the following:

## **INSIDE INFORMATION**

In relation to the "other relevant information notice" (*comunicación de otra información relevante*) dated July 1, 2025 (official registry number 35597) with regard to the approval and registration of the Prospectus, Cirsa informs that the bookbuilding process for the Offering has successfully concluded.

On the date hereof the Company, LHMC Midco and the Managers have entered into the underwriting and placement agreement relating to the Offering (the "**Underwriting and Placement Agreement**"). The identity of the Managers and the percentage of the Initial Offer Shares underwritten by each of them have not changed with respect to those stated in section "*Plan of Distribution—The Underwriting and Placement Agreement*" of the Prospectus.

Capitalised terms used but not defined herein shall have the meaning given to such terms in the Prospectus.

Pursuant to the Underwriting and Placement Agreement, the Company and LHMC Midco, each of the directors of the Company and the Management Shareholders have agreed to certain lock-up arrangements with the Managers during a period from the date hereof to and including 180 calendar days from Admission (in the case of the Company and LHMC Midco along with their respective subsidiaries) and 365 days from Admission (in the case of the directors of the Company and the Management Shareholders), in each case subject to certain exceptions or waiver by a majority in number of the Joint Global Coordinators.

According to the tentative calendar of the Offering (detailed in section "*Plan of Distribution—The Offering*" of the Prospectus), trading of the Shares on the Spanish Stock Exchanges will commence on July 9, 2025.

Each of the dates included in the tentative calendar of the Offering is subject to change without prior notice. Any change will be made public by means of publishing the



corresponding inside information notice (*comunicación de información privilegiada*) or an other relevant information notice (*comunicación de otra información relevante*) with the CNMV.
